Minutes of the Meeting of the State Level Committee on NGOs/VOs held on 20/03/2010 in the Secretariat Conference Hall to discuss proposals of NGOs for financial assistance from Central Ministries.

List of participants is at Annexure-I.

2. There were 16(sixteen) project proposals of NGOs placed before the State Level Committee on NGOs/VOs. Each NGO's representatives and concerned officials were heard and after thorough discussion the Committee **recommended** the project proposals of NGOs listed at **Annexure-II**.

3. Further, it was also decided that all the concerned Administrative Secretaries/ Heads of Deptt/ NGOs/VOs shall:

- (i) Invite NGOs/VOs through local newspapers who are interested in applying schemes which are funded under NGO schemes by the concerned Ministries from time to time. **(Action: Line Deptts)**
- (ii) Forward the proposals of NGO to the Planning Department along with relevant documents which ensure that the applied schemes are funded by the concerned Ministries including M/o DoNER, NEC **(Action: Line Deptts)**
- (iii) Check-list of the proposals duly authenticated by the concerned Heads of Department should be accompanied failing which the proposal will not be placed before the State Level Committee for discussion. **(Action: Line Deptts)**
- (iv) Forward the proposals recommended by the State Level Committee to the concerned Ministries after getting Administrative Approval. **(Action: Line Deptts)**
- (v) Request the Ministries concerned for endorsing a copy of the sanction/release order to the Planning Department while forwarding the proposals. **(Action: Line Deptts)**
- (vi) Issue a notice through local newspapers about the salient features of the project once the Ministry sanctions the project indicating the cost of the project, funding received from the GOI, project duration, objective, targeted beneficiaries, benefits, etc **(Action: NGO/VOs)**
